 - The visit will be treated as ex-Bangladesh leave (personal).
 - The incumbent shall draw his pay and allowances for the time stipulated in local currency and no part thereof should be drawn in foreign currency.
 - Overstay will not be permitted.
 - After return he will submit joining report to his authority.

03. The Administrative order No.43.00.0000.116.08.015.17.343 issued on 30.07.2017 is hereby cancelled.


